





#### Portable Fire Extinguishers

- Attended SS must have at least 2 extinguishers rated 4A:60BC.
- Unattended SS need 1
   extinguisher at each
   island and at the E-Stop.
- USS may also have a Suppression System.
- "Standard for Portable Fire Extinguishers" NFPA 10 (2007) incorporated by reference.

### Other UST Activities Inspected: Installations & Decommissioning

- In addition to local building codes, MFDFs must also pass a permit application review:
  - New Facility
  - New dispensers/islands/tanks
  - Significant Upgrades to UST components or safety equipment
  - Change to a different type of MFDF
  - Repairs to UST components



#### Requirement for UST Contractors to be OSFM Licensed

- Statutory Basis for our contractor rules:
   Petroleum Equipment Contractors Licensing Act (PECLA) [225 ILCS 729]
- State Regulations are at 41 IAC 172
- UST Contractor Licenses cover 5 Modules:
  - Tank Tightness Testing
  - Install/Retrofit
  - Cathodic Protection
  - Decommissioning
  - Lining

### More New Installation: Under Dispenser Containments (UDCs)





#### Inspection of Tank(s), Piping, Site

- Inspect Tank and piping for any damage from shipping
- Verify all equipment as specified on permits & by regulations (2-wall)
- Verify layout & placement conforms with site drawing
- Is excavation safely sloped or shored?
- Is anchoring installed for tank(s)?



#### This is why you anchor your USTs





### Side View of the same USTs...Yes, that is concrete!





#### Air Tests; Hydrostatic Tests

- Tank(s) interstice tested for air tightness
- Pipe interstice tested for air tightness x 2
- Containments & Sumps tested for water tightness
- Verify Overfill Prevention Devices
- Verify proper venting
- Return for a complete Certification Audit before a Green Decal & MFDF are issued



#### Wrapping Things Up...

#### P&CS Mission Statement

... to protect against threats to human safety and contamination of the environment that can occur by the underground storage of petroleum products and other hazardous substances through prevention, education and enforcement.



#### Prevention

- Establish UST Rules, Regulations & Requirements
- Review applications for permits to install, repair, improve and remove USTs and equipment
- Inspect equipment and work on job sites, supervise safe work practices at UST installs & removals
- Inspect UST facilities every 2 years, and follow up on any violations



#### Education

- UST Contractor licensing, with mandatory OSHA training annually & mandatory module testing every 2 years
- Owners/Operators of UST facilities required to certify as A/B or C Operators every 2 years
- Field & Office Staff continually answering questions and explaining regulations to contractors, owners/operators & public



#### Enforcement

- Notice of Violation written for noncompliance
- After 60 days of NOV period, continued noncompliance will result in UST(s) being Red Tagged
- Further noncompliance can result in Administrative Order to remove UST(s) from OSFM Legal Staff
- Continued noncompliance may end up referred to Illinois Attorney Generals Office, and possible civil or criminal penalties being assessed
