If you are a member of NFPA you should attend the virtual voting this summer. We have been told that there will be efforts to once again remove the statement of "with the approval of the AHJ" from remote station monitoring in NFPA 72. If this is approved, then an alarm company could, without your approval, send signals to any receiving stating. If you disagree with this, it is important that you vote in June. As we receive more information on this, we will, of course, keep you informed. Also, check with your building officials, they may be NFPA members and would be able to vote.
